Work includes providing materials and services to remove all contaminated insulation materials in the furnace space of the primary Refuge house. This project will remove both asbestos and non-asbestos-containing insulation currently in this space to prepare for furnace ducting replacement work and re-insulation of the attic space. Interested parties must be experienced, California-certified for asbestos removal, and have demonstrated positive past performance with abatement and disposal of asbestos-containing materials. A site visit is scheduled for Tuesday, December 17, 2024, at 1:00 PM PST. Note that the Refuge cannot accommodate unplanned site visits; please do not show up without approval. **NAICS:** 562910. THIS IS A SOURCES SOUGHT NOTICE FOR MARKETING RESEARCH PURPOSES ONLY. The U.S. Department of the Air Force requires a contractor to abate and remove asbestos-containing material (ACM) in an existing construction site in Building 1300 at Mountain Home Air Force Base in Idaho. Walls have been removed and opened to expose the ACM. Abatement needed includes eight 10' HVAC pipes that can be cut and removed. Also, a 10' water-insulated water pipe needs insulation removed from the pipe while the pipe must remain in place. Stick-framed walls were removed and left approximately 60' x 4" residual VCT needing abatement. Beneath a layer of sheet vinyl, 192 square feet of ceramic tile requiring abatement was discovered. The U.S. Army Corps of Engineers, Detroit District, is seeking professional industrial hygiene services for the abatement and disposal of floor tile and mastic, wall panels, and pipe covering in the Maintenance and Support Building (MSB) located at the St Mary's Falls Canal at 119 E. Water Street in Sault Sainte Marie, Michigan. The U.S. Department of Veterans Affairs anticipates issuing a solicitation for a construction project to perform the removal and disposal of asbestos-containing materials (ACM) from the Veterans Canteen Service Storage Room 105, Canteen Office Area Room 114 and 114B, and the Retail Store Area Room 112 in Building 3 at the VA Medical Center in Fayetteville, North Carolina. The U.S. Army Corps of Engineers (USACE), Pacific Ocean Division (POD), Alaska District (POA) requires services necessary to execute projects under the Environmental Remediation Services (ERS) Program. Requirements will support the emergency response required of POA under the federal National Contingency Plan for oil spills and hazardous substance releases (40 CFR Part 300 - National Oil and Hazardous Substances Pollution Contingency Plan).
