The technical approach must respond to each of the following scenarios in accordance with the requirements in the SOW: 100 gallons of Jet-A fuel went down a storm drain. 1500 feet of storm drain piping needs to be flushed, and the fuel removed and disposed; and 50 gallons of fuel oil leaked into soil. 20 yards of soil needs to be excavated and placed into a roll-off.
