The U.S. Department of Veterans Affairs seeks responses from interested firms qualified to perform abatement of asbestos-containing materials (ACM) in Building 219 at the White City, Oregon, VA Southern Oregon Rehabilitation Center and Clinics (VA SORCC). There are four rooms (approximately 416 sq. ft.) that need the Acoustic Ceiling Tile (ACT) removed and replaced along with six lights, and two vent fans. Above the ACT ceiling on the ceiling structure contains ACM tiles that need abatement. The room numbers are 105, 106, 108, and 109 in Building 219. This project must be done in two different phases. Rooms 105 and 106 will be one phase, and then rooms 108 and 109 will be another phase. This always allows Canteen Services access to their storerooms 104 and 107 during construction. The removal of items will need to follow ACM removal and ICRA procedures to prevent contamination of the area and people outside of ICRA barriers. Materials in Rooms 108 and 109 must be removed through the window. The award will be a Firm-Fixed-Price contract with a period of performance 90 days from Notice to Proceed. F -- REMEDIAL ACTION OPERATIONS AT FORMER FORT DEVENS, DEVENS, MASSACHUSETTS (SOL)

The U.S. Army Corps of Engineers requires an environmental services contractor to support activities at former Fort Devens and the former Sudbury Training Annex on behalf of the Army under the BRAC Program. This contract will be a Single Award Task Order Contract (SATOC) Indefinite Delivery/Indefinite Quantity (ID/IO) contract set-aside competitive acquisition action under the U.S. Small Business Administration (SBA) 8(a) Business Development Program. The major efforts under this SATOC will generally include environmental services at various sites related to (1) long-term monitoring; (2) operations and maintenance activities including landfill inspections; (3) remedial action operations; and (4) community relations support. The main contaminants detected at former Fort Devens include but are not limited to: solvents, petroleum and metals. This SATOC will also include environmental services related to addressing per- and polyfluoroalkylated substances (PFAS), which are present in soil and groundwater at multiple sites and currently in the remedial investigation phase of the CERCLA process. The efforts for the PFAS work may include: additional investigation; preparing remedial investigation reports, feasibility study reports, proposed plans and record of decisions; conducting pilot tests; implementing interim remedial action such as installation of point of entry treatment systems and implementing final remedial actions as specified in the record of decision.
