F -- HAZARDOUS MATERIALS CLEANING AND SOIL SAMPLING SER (COMBINE)

NAICS: 562910. THIS IS A TOTAL SMALL BUSINESS SET-ASIDE. The U.S. Department of the Interior, National Park Service (NPS), requires a contractor to clean metals-contaminated items and interior surfaces of Building T-1111 at Fort Cronkhite in the Golden Gate National Recreation Area, Sausalito, California. Building T-1111 has long served as a storage and supply warehouse and was recently assessed to contain lead-based paint on its exterior walls and stairs, as well as chromium, lead, and mercury in interior dust. The contractor shall provide a work plan, a Health and Safety Plan (HASP), and all services necessary to conduct cleaning activities - including sweeping, bagging, wiping, HEPA-vacuuming, and ladder use - on high-priority non-porous items and high-touch interior components during a single four-hour shift, sufficient for an independent oversight Industrial Hygienist Consultant to evaluate exposure concentrations extrapolated to an eight-hour shift. A separate NPS contractor will conduct air monitoring for metals for each of the typical cleaning/work tasks mentioned above. The Government intends to award a single, firm-fixed-price contract with a period of performance from September 30 through December 30, 2025. OFFERS ARE DUE BY 3:00 PM PDT ON SEPTEMBER 5, 2025.

F -- F108-- REMOVE ASBESTOS CRITICAL AREAS LYONS (SOL)

SOL: 36C24225Q0954

DUE: September 8, 2025

NAICS: 562910. THIS IS A TOTAL SMALL BUSINESS SET-ASIDE. The U.S. Department of Veterans Affairs requires a New Jersey-licensed asbestos contractor to abate asbestos-containing materials (ACM) identified throughout the Lyons Campus of the VA New Jersey Healthcare System. ACM has been found on leaking steam condensate piping, which cannot be repaired until abatement is completed. To prevent further damage to critical hospital areas, the steam condensate piping has been shut off, resulting in no heat in many areas. The contractor shall prepare the site for building operations, including demolition, removal, disposal of ACM, and restoration of affected areas. Work shall be completed in multiple phases coordinated with the clinical schedule to minimize disruption to patient services and access. The contractor shall perform abatement at three locations: approximately 50 linear feet (LF) of pipe insulation in Building 10; approximately 50 LF of pipe insulation in Building 11; and approximately 30 LF of pipe insulation in Building 2, Room 26, including removal and reinstallation of ceiling tiles and grid as necessary. All work shall be performed during normal business hours (6:00 a.m. to 6:00 p.m.) in compliance with confined space requirements and all applicable local, state, and federal laws and codes. The contractor shall provide a per linear foot price for asbestos abatement for any additional linear foot that needs to be added to the approximate linear feet that is indicated in the contract. The awarded contract will have a 45-calendar-day period of performance from the

F -- CLEANING OF ASBESTOS - CONTAMINATED CRAWL SPACES (EISENHOWER LOCK TUNNEL) (COMBINE)

NAICS: 562910. THIS IS A TOTAL SMALL BUSINESS SET-ASIDE. The U.S. Department of Transportation, Great Lakes St. Lawrence Seaway Development Corporation (GLS), requires a contractor to clean two crawl spaces containing asbestos-containing material (ACM) and two areas containing dust above the Eisenhower Lock Tunnel in Massena, New York. This project involves the cleaning and abatement of asbestos-containing material (ACM) in two crawl spaces above the Eisenhower Lock Tunnel in Massena, NY. Each crawl space is approximately 37 feet deep, 30 feet wide, and 2.5 feet tall, and contains transite cementitious conduit (4 inches in diameter) with approximately 2.3% Crocidolite and 8.8% Chrysotile asbestos. Broken sections of conduit and debris on the floor may require removal, and conduits identified by GLS personnel as containing dead or inactive wires will also be removed. Additional tasks include clearing miscellaneous debris such as batt insulation and wood scraps, as well as performing dust cleanup in the two access areas leading to the crawl spaces, each measuring about 140 feet long by 30 feet wide. Access is limited and requires entry through hatches above the tunnel, descending stairs, and walking to the work location. All work shall be performed under confined-space conditions in full compliance with applicable federal, state, and local regulations. The award will be a firm-fixed-price contract with a 30-calendar-day period of performance from the Notice to Proceed. OFFERS ARE DUE BY 2:00 PM EDT ON SEPTEMBER 9, 2025.
